This privacy policy explains how personal data is collected and used in accordance with the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018.

Who we are

Heather George, trading as Omtropy, is a sole trader providing online Yoga, Pilates and Meditation classes via Zoom.

Personal data

We do not use cookies, analytics or collect personal data on www.omtropy.com

Health Information

If you register for classes, we may ask you to provide health information relevant to participating safely in Yoga, Pilates, or Meditation. This may include details about injuries, medical conditions, or other factors affecting your ability to take part.

Health data is collected and stored in Microsoft Forms and is processed in accordance with Microsoft's own privacy policy.

All health information is stored securely and accessed only by authorised personnel. We retain it only for as long as necessary for class participation or legal obligations, after which it is deleted.

We process this information on the basis of your explicit consent. Your health information is used only for the purpose of ensuring your safety during classes and is not shared with third parties.

Zoom classes

Our classes are delivered live via Zoom.

- You may choose whether your camera is on or off, all students will be muted;
- We do not record classes unless this is clearly stated in advance. When we do record classes, we only record the visual and audio of the teacher. Students will be muted and we will not refer to them by name during the class

- Any personal data you provide directly to Zoom is processed in accordance with Zoom's own privacy policy

Bookings, payments and third-party services

All class bookings and payments are handled by Momoyoga a separate third-party booking and payment platform linked to Stripe for card payments.

These platforms act as independent data controllers for booking and payment information. We do not have access to your payment details.

What we do not do

- We do not use cookies
- We do not use analytics or tracking tools
- We do not sell, share, or rent your personal data
- We do not pass your data to third parties for marketing purposes

Lawful basis for processing

Under UK GDPR, we process your personal data on the basis of:

- Consent – where you have asked us to contact you or keep you informed, and/or
- Legitimate interests – to communicate information relevant to the services you have requested

You may withdraw your consent at any time.

How your data is stored

Your personal data is stored securely and accessed only by the sole trader. We retain your data only for as long as necessary for the purposes outlined in this policy, or until you ask for it to be deleted.

Your rights under UK GDPR

You have the right to:

- Request access to the personal data we hold about you
- Request correction of inaccurate or incomplete data
- Request deletion of your data
- Object to or restrict processing
- Withdraw consent at any time
